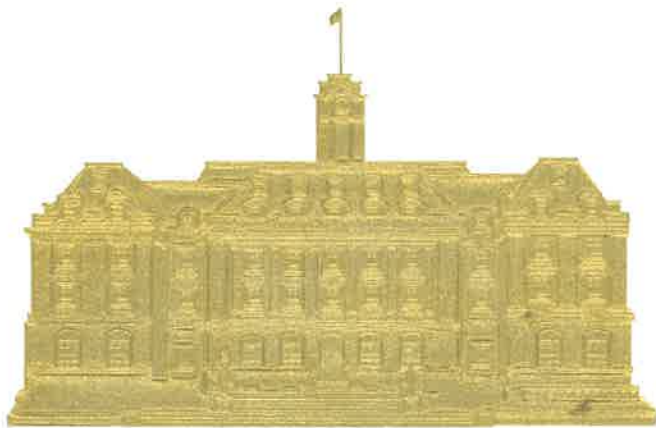

Whereas: RUMC is currently working to expand its child psychiatric unit to provide more children and adolescents with quality psychiatric care close to their homes and families; and


